General Public	Economic Development Strategies need to be expanded throughout the fishing and oil and gas industries
General Public	The State of Louisiana should look further into the wetlands' ability to sequester carbon. The group determined that this was more of a General Task force issue.
General Public	The session attendees did not like that the environmental issues had already been pre-determined, and put up on posters. The Session attendees would like a blank slate and determine the issues themselves.
General Public	One of the main environmental stressors is marine trafficking (commercial trafficking). Louisiana has a major problem with the federal navigation channels and does not have the resources to mitigate the problem. Rock needs to be placed along the navigation channels. Significant losses are occurring due to trafficking and erosion. This is a specific issue between the State of Louisiana and the Corps of Engineers. CWPPRA is not contributing resources. Federal money is the only money that is being provided at this time.
General Public	Restoring the Gulf to pre-storm conditions should be the priority. The major issue Louisiana is facing is subsidence. The BP event ignored safe, proven restoration methods, and new unproven methods were used by BP and the Federal Government. Oil and dispersants increased the toxins in the water. The dispersants used to sink or disperse the oil has caused the problems, and the public has been getting sick.

	Also, the Government needs to have more transparency. Between health and public safety there should be no divergence. Letters addressing this issue have been sent to both the Federal and State Governments and have received no response. Task Force Response - The audience for your comments is the NRDA public hearings. The NRDA process is running concurrent with the Gulf Task Force and is not a part of the process of these Restoration Task Force meetings.
General Public	Inland Waterways Trust Fund needs more resources to address subsidence and erosion of the navigation channels.
Business & Industry	There is a serious health issue associated with the oil spill that the Government is ignoring. To date there are 120 dead dolphins, and this needs to be recognized as an unusual mortality event. Carcinogenic dispersants was used, and we have to address what needs to be done about this, literally from the bottom up. How do we get the oil off of the bottom of the Gulf? Also, the carcasses of these dolphins are being left on the beach.
General Public	There is a lack of transparency that is occurring regarding the restoration effort, and a "blame game" of pitting one business against another. The way this was addressed during the Exxon Valdez Oil spill is that a General Publics Advisory Council was established. This council served as a go between and facilitated consensus decision making between the entire business and industry sector. The task force should consider this legal mechanism that can represents all concerns of the business and industry. 80% of the Clean Water Act fines collected from BP should be applied to Louisiana and other hit communities. These monies should be used for restoration and for economic development along the Gulf.
	Not all businesses are being represented at these Task Force meetings. The Task Force needs to create a system and a structure that will be long lasting, and will ensure all industries representation on this Task Force.
